

COMMITTEE MEMBERSHIP

Species at Risk Committee members are appointed by the four wildlife co-management boards established under settled land claim and self-government agreements, the federal government and the Government of the Northwest Territories, represented by the Minister of Environment and Natural Resources (ENR). In areas without settled land claims, members are appointed by the Minister of ENR after consultation with the appropriate groups. Appointments are for up to five years.

Committee members must have significant expertise of species, habitat, northern ecosystems or conservation. Members act independently and not as representatives of their appointing bodies.

ANNUAL REPORT

Under section 23(1) of the *Species at Risk (NWT) Act*, the Species at Risk Committee must submit an annual report to the Conference of Management Authorities by July 1 each year. This annual report covers the fiscal year ending March 31, 2011.

THE *SPECIES AT RISK (NWT) ACT*

The *Species at Risk (NWT) Act* (the Act) provides a process to identify, protect and recover species at risk in the Northwest Territories (NWT). The Act applies to any wild animal, plant or other species managed by the Government of the Northwest Territories (GNWT). It applies everywhere in the NWT, on both public and private lands, including private lands owned under a land claims agreement.

COMMITTEE PROGRESS
APRIL 1, 2010 TO MARCH 31, 2011

The Species at Risk Committee held four meetings and finalized the following documents:

- Species at Risk Committee Rules of Conduct;
- Checklist to Prioritize Species for Assessment;
- Species Assessment Process and Objective Biological Criteria; and
- Guidelines for Species Status Reports.

The Committee used its priority checklist to identify 19 species for assessment under section 25(2)(a) of the Act. An assessment schedule for 2012–2016 detailing species to be assessed over the next five

years has been developed. The five-year assessment schedule has been approved by the Conference of Management Authorities. The assessment schedule will be revised annually.

The Species at Risk Committee has started work on species status reports for Peary caribou, hairy rockcress, polar bear and boreal woodland caribou. No species have been assessed to date. The Committee did not receive any referrals or applications for species to be assessed under sections 26(1) or 27 of the Act during the 2010–2011 fiscal year.

THE SPECIES AT RISK COMMITTEE

The Species at Risk Committee (the Committee) was established under the Act. It is an independent committee of experts responsible for assessing the biological status of species at risk in the NWT.

Species status assessments will be done at the territorial level and results may be different from assessments done at the national level. Assessments will be based on species status reports that include the best available Aboriginal traditional knowledge, community knowledge and scientific knowledge of the species. The Committee must use objective biological criteria in its assessments and does not consider socio-economic factors.

The Committee will use the assessments to make recommendations on the listing of species at risk. The assessment categories for the legal list of species at risk are Extinct, Extirpated, Endangered, Threatened and Special Concern. Species can also be assessed as Not at Risk or Data Deficient. The Committee will identify threats and positive influences to species and their habitats, and may make recommendations on conservation measures for species at risk.

The Committee makes its recommendations to the Conference of Management Authorities, a group of boards and governments that share responsibility for the conservation and recovery of species at risk in the NWT. The Conference of Management Authorities includes wildlife co-management boards established under land claim and self-government agreements, the Government of the Northwest Territories, the Tłı̨chǫ Government and the Government of Canada.
