Approval Process

Recall that progress reports and reviews are required under sections 73 and 74 of the *Species at Risk (NWT) Act*. However, the Act does not indicate a process for approving these documents.

How does the CMA foresee the approval process for these documents going? What steps will Management Authorities need to take to approve the species progress reports/review (for instance, will these documents be approved at board meetings)?

Approval options:

- Approval during CMA meetings (like the meeting minutes and other decisions) with the approval shown in the minutes.
- A separate meeting with the species management authorities to approve.

The CMA noted a practice of sharing documents with board members and would like to have the final draft progress report and review documents in August to allow time for inclusion in fall board meetings. The CMA noted that the process for approval may depend on the species reported on and that some species may require more formal approvals. The CMA agreed that final approval for progress reports will be stated during a CMA meeting and the decision will be captured in meeting notes.

Decision D20210917-01: The CMA agreed that final approval of species progress reports and reviews will take place and be recorded during CMA meetings.

- Boreal caribou
- Amphibians (Northern leopard frog and Western toad)
- Polar bear

Progress reports and reviews are required 5-years after an implementation agreement is signed. Boreal caribou and amphibians are due in November 2022 while polar bear is due in March 2023 (4 months after boreal caribou and amphibians). The Secretariat is suggesting lining polar bear up with the November 2022 deadlines. The February implementation summaries are used to inform the progress reports/reviews, so this would also align with when Management Authorities submit implementation summaries (rather than a month before summaries are due).

The Secretariat provided a brief overview of the progress report and review workplans for boreal caribou, amphibians and polar bear. The Secretariat will revise the workplans to line up with board meetings and to provide the final draft for approval in August.

GNWT agreed that lining up the timelines but expressed concern for the Secretariat's workload. The Secretariat is anticipating that much of the work for the progress reports will be drafted in the fall/early winter.

Action A20210917-03: The Secretariat will revise the workplans for boreal caribou, amphibians and polar bear to line up with board meetings and plan to provide the final draft progress reports and reviews for approval in August.

Decision D20210917-02: Decision to prepare the polar bear progress report and review under the same timeline as the boreal caribou and amphibians reports/reviews (November 2022).

The CMA discussed the need for a press release to satisfy the requirement under section 73 of the Act to make the progress report public. A press release would spread awareness about the objectives, approaches and actions that the Management Authorities and participants of the CMA have completed or are working toward for species management, conservation and recovery in the NWT. A press release on the progress report would help get the message out that the CMA is not just listing species but it would also highlight the work that the CMA is doing to implement actions. In some ways, a progress report is about accountability and reminds people that the CMA is working to make things better for species.

The CMA supports a press release and would like an opportunity to review and respond to what is being reported.

Polar Bear Joint Management Plan

The polar bear management plan is a joint plan and thus requires some additional discussion. The CMA Management Authorities for polar bear are WMAC-NWT and ENR; and the ISR polar bear management agencies are WMAC-NWT, WMAC-NS and Inuvialuit Game Council.

[Excerpt from the Polar Bear Joint Management Plan]: *Five years after the signing of the plan, the management agencies for polar bear in the ISR will report on progress under this management plan.*

In five years the management agencies for polar bear in the ISR will formally report on progress under this management plan. In ten years, or at the request of a management partner, this management plan and the accompanying Framework for Action will be reviewed and revised as required. This process will continue as long as polar bear is listed as a species of special concern under the Species at Risk (NWT) Act and/or the federal Species at Risk Act (SARA).

Prior to starting work on the polar bear progress report and review, the Secretariat will need direction. Some questions to consider:

- When were the management agencies in the ISR planning to do a 5-year report on progress?
- Should we consider a joint progress report and review?

Updates on consultation and engagement

- **WMAC-NWT:** WMAC-NWT is looping in species consultation/engagement with community visits that will occur in early October to November, all 6 communities. WMAC-NWT will provide an update after that in December.
- **GNWT:** GNWT is advertising a public comment period inviting anybody to comment on the potential relisting and have requested comments by October 15. The public comment period is being shared in a few different ways and the GNWT will be sending letters to IGOs – they anticipate that those letters will be out shortly.

8. Northern mountain caribou – led by Mélanie Routh, Secretariat

Management plan proposed approach and outline. Presentation by SRRB

Presentation by Deb Simmons (SRRB) on the Nío Nę P'ęné plan

Deb Simmons provided a presentation on the Nío Nę P'ęné plan including the community conservation plan approach which is an adaptation of the Healthy Country Planning approach. The three key principles of the Nío Nę P'ęné plan include: Biocultural Diversity, Self-Regulation, and Ethical Space.

The presentation also reviewed the complimentary goals between the federal *Management Plan for the Northern Mountain Population of Woodland Caribou (Rangifer tarandus caribou) in Canada* and the *Nío Nę P'ęné Begháré Shúhta Goęepé Narehzá – Trails of the Mountain Caribou Management Plan*. The federal management plan seeks to prevent the northern mountain caribou from becoming threatened or endangered, by having responsible agencies cooperatively work together to carefully manage these caribou and their habitat. The Nío Nę P'ęné Plan indicates that if communities are healthy, including economies, then caribou are still healthy (increase numbers). Both plans have objectives in stewardship, landscape/habitat conservation, cumulative impacts, research and monitoring.

The presentation also mentioned that the Canadian Mountain Network recently funded a Hub (corridor of land in the Mackenzie Mountains).

The CMA discussed the differences between the Níó Nę P'ęné plan and the federal management plan and how SRRB foresees braiding the two.

Both plan address similar topics and do not have conflicting objectives. The Níó Nę P'ęné plan has a biocultural diversity approach rather than just biodiversity approach. A lot of work [in the Federal Management Plan] does not include Article 8J of the Convention on Biological Diversity, which points to the role of Indigenous people in decision making. Braiding science and Indigenous knowledge is essential. Research questions are not just around biology, but also questions around place names and stories and governance, as well as economic questions.

Management plan proposed approach

On July 29, 2021, northern mountain caribou (*Rangifer tarandus caribou*) were listed as a species of Special Concern in the NWT by the Minister of ENR. Under the *Species at Risk (NWT) Act*, this means that a management plan must be completed within 2 years of its listing (by July 2023). During the February 2021 CMA meeting, Management Authorities agreed to adopt the federal *Management Plan for the Northern Mountain Population of Woodland Caribou (Rangifer tarandus caribou) in Canada* as a nested approach using the national management plan as a high-level umbrella plan covering the entire NWT range. In addition, the management plan will point to the Sahtú community-led plan (*Níó Nę P'ęné Begháré Shúhta Goǰepé Nareǰá – Trails of the Mountain Caribou Management Plan*) as an important regional initiative that gives applied direction on how to conserve caribou in the area of the Sahtú that is covered by the management plan. This approach would recognize and support the good work that has already been completed, and that is underway, to plan for northern mountain caribou conservation in the NWT. Therefore, more time and resources can be focused on the implementation of northern mountain caribou conservation actions rather than developing a new management plan.

The *Management Plan for Northern Mountain Caribou in the Northwest Territories* will adopt the federal *Management Plan for the Northern Mountain Population of Woodland*

Caribou (Rangifer tarandus caribou) in Canada as it is (i.e., no modifications/revisions), but will also include the content listed above to fulfill the requirements for a management plan under the *Species at Risk (NWT) Act*.

The Secretariat (Mélanie Routh) provided the CMA with a thorough overview of the northern mountain caribou management plan proposed approach and outline. The CMA determined that the proposed approach is longer than anticipated and they would like something shorter (1–2 pages) than what is being proposed by the Secretariat. The CMA suggested including only a couple of paragraphs in Part 1 of the management plan (i.e., CMA's addition to the federal management plan) which points to the SARC status report and the Sahtú community-led plan as a place for additional and up-to-date information on northern mountain caribou in the NWT, Management Authorities envisioned that rather than only focusing on the Nío Nę P'ęñę Plan (Sahtú community-led plan) that it should be highlighted, noting that it is currently being approved through a process.

Concern was also raised with regard to pointing to other community-led conservation plans in other regions [outside of the Sahtú]. We want to make sure that other parts of the NWT and the people that are most closely related to caribou (the stewards) are appropriately reflected.

The federal management plan does lack Indigenous and Community knowledge, however, it was noted that the process for the development of the federal management plan was a collaborative process that included GNWT, SRRB and GRRB. The CMA suggested referring to the SARC status report and regional community-led plans for information on Indigenous and community knowledge as well as more recent species information (e.g., population, distribution, and threats).
